

PRIVACY POLICY

Infospectrum Limited ("We") are committed to protecting and respecting your privacy

This policy (together with our terms and conditions of sale/supply <http://www.infospectrum.net/reportingservices/tcpopup.asp> and any other documents referred to on it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following personal data:

- Information that you provide or have previously provided by filling in forms on our site <http://www.infospectrum.net> (**our site**). This includes information provided at the time of registering to use our site, subscribing to our service or our buying our reports, posting material or requesting further goods or services, information you supply in course of using our products and services, or paying for our products and services (including payment card or other payment information). We may also ask you for information when you report a problem with our site.
- If you contact us, we may keep a record of that correspondence and any information contained in it.
- Details of transactions you carry out through our site and the fulfilment of your orders.
- We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- Details of your visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

IP ADDRESSES AND COOKIES

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate

information to our advertisers. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help us to improve our site and to deliver a better and more personalised service. They enable us:

- To estimate our audience size and usage pattern.
- To store information about your preferences, and so allow us to customise our site according to your individual interests.
- To speed up your searches.
- To recognise you when you return to our site.

You may refuse to accept cookies by activating the setting on your browser, which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of our site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you log on to our site.

Please note that our advertisers (if any) may also use cookies, over which we have no control.

WHERE WE STORE PERSONAL DATA

The personal data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for us. Such staff maybe engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of marketing and/or support services.
